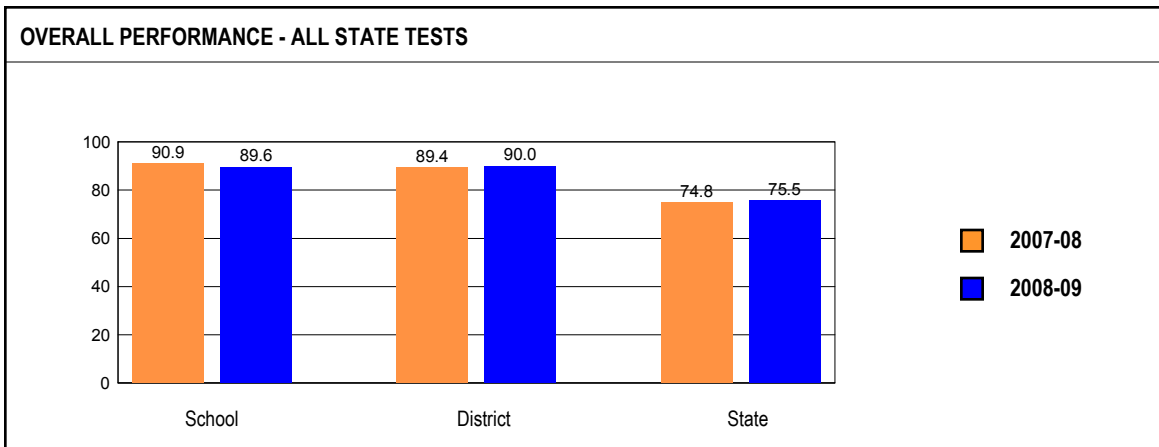

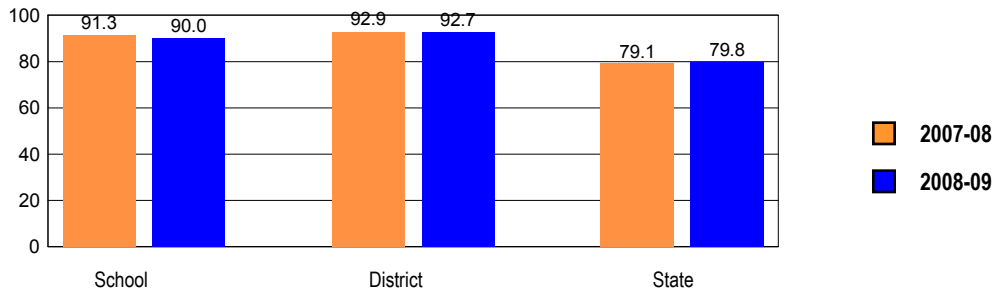
### OVERALL STUDENT PERFORMANCE

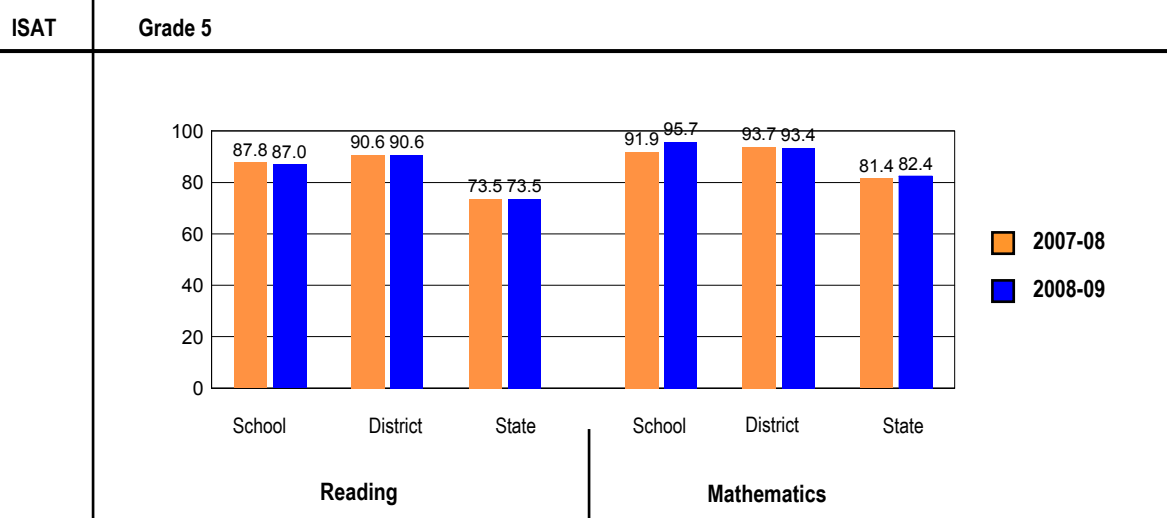
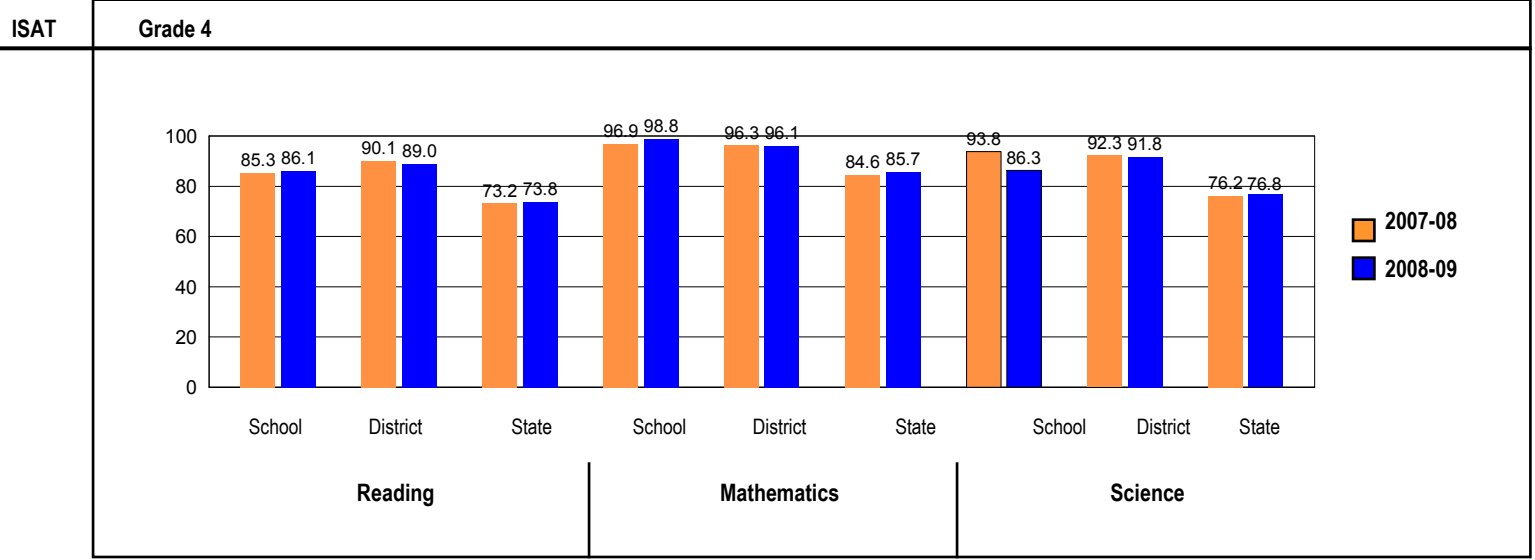
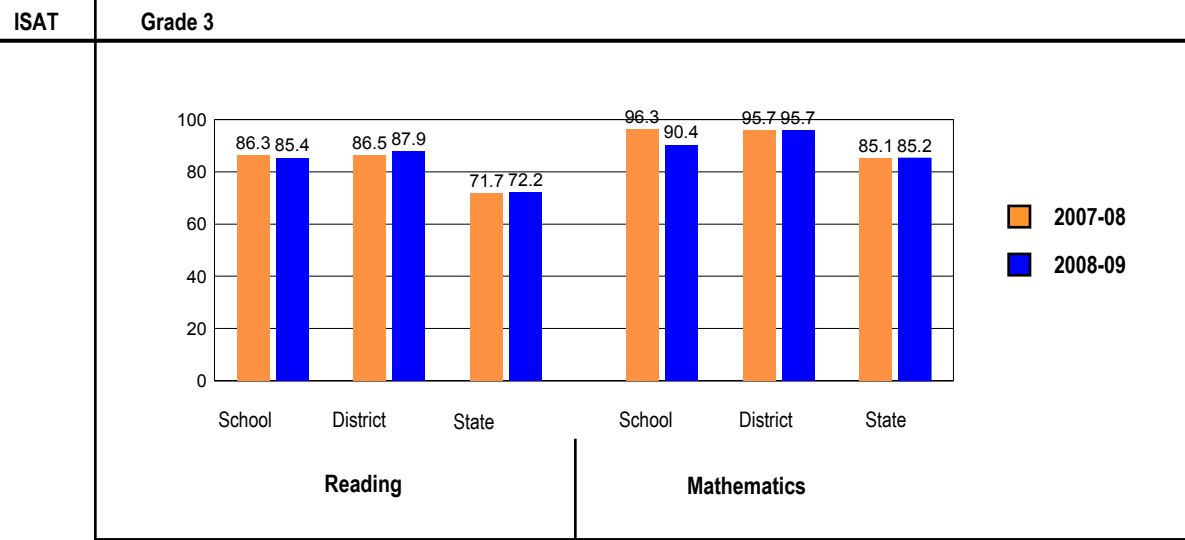


**OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE**

## PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

### ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

- Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.
- Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.
- Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.
- Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

### Four Conditions Are Required For Making Adequate Yearly Progress (AYP):

1. At least 95% tested in reading and mathematics for every student group. If the current year participation rate is less than 95%, this condition may be met if the average of the current and preceding year rates is at least 95%, or if the average of the current and two preceding years is at least 95%. Only actual participation rates are printed. If the participation rate printed is less than 95% and yet this school makes AYP, it means that the 95% condition was met by averaging.
2. At least 70.0% meeting/exceeding standards in reading and mathematics for every group. For any group with less than 70.0% meeting/exceeding standards, a 95% confidence interval was applied. Subgroups may meet this condition through Safe Harbor provisions. \*\*\*
3. For schools not making AYP solely because the IEP group fails to have 70.0% meeting/exceeding standards, 14% may be added to this variable in accordance with the federal 2% flexibility provision.
4. At least 90% attendance rate for non-high schools and at least 78% graduation rate for high schools.

\*\*\* Subgroups with fewer than 45 students are not reported. Safe Harbor only applies to subgroups of 45 or more. In order for Safe Harbor to apply, a subgroup must decrease by 10% the percentage of scores that did not meet state standards from the previous year plus meet the other indicators (attendance rate for non-high schools and graduation rate for high schools) for the subgroup. For subgroups that do not meet their Safe Harbor Targets, a 75% confidence interval is applied. Safe Harbor allows schools an alternate method to meet subgroup minimum targets on achievement.

## **Munhall Elementary School Improvement Plan for 2009-2010**

This “School Report Card” has been compiled by the Illinois State Board of Education as a means by which school districts communicate local and statewide information to the public. The No Child Left Behind Act of 2001 (NCLB) requires states to establish annual achievement targets which are used to calculate Adequate Yearly Progress (AYP). The purpose of this “School Report Card” is to communicate the school’s and district’s performance under the annual targets. Our goal is to provide all students an educational environment that supports them both academically and emotionally.

Munhall Elementary School is committed to:

- Fostering a community of critical, creative learners
- Establishing an educational foundation for all students in their journey as life-long learners
- Building the capacity of all learners to meet life’s demands with confidence
- Providing an environment that is safe and respectful for all learners

### **Findings for the Improvement Plan**

The Munhall Building Leadership Team reviewed a number of data sources to determine our school improvement goals. We analyzed data from the Illinois Standards Achievement Test (ISAT), Tungsten Benchmark Assessments, District Affective Survey, and other local and building level assessment data. The ISAT test was given to third, fourth, and fifth grade students this past spring. At grade three, 85% of our students met or exceeded standards in reading and 90% in math. At grade four, 86% of our students met or exceeded standards in reading and 99% in math. Fourth grade students also took the science test with 86% of the students meeting or exceeding standards. At fifth grade, 87% of our students met or exceeded standards, and 96% met or exceeded standards in math.

### **Goals for the Current Year**

The Munhall School Improvement Team analyzed the data to determine strengths and areas for improvement. Based on this work, the Munhall School Improvement Plan was developed to focus on an academic and affective goal. Our academic goal is to increase the total percentage of students in grades 3, 4, and 5 who meet or exceed state standards by 2% in reading and by 1% in math. As a building we utilize the professional learning community process to focus on student learning, ensuring all students’ access to the Core Curriculum and best instructional strategies. Collaborative teams meet on a regular basis to analyze and discuss common formative assessment data to determine curricular focus and to plan interventions. Specifically, we will target students who are at risk for not meeting grade level expectations as identified by 2008-2009 ISAT data and current formative assessment data. We will monitor our students’ progress using assessment data.

Also, through our Social Decision Making and Problem Solving curriculum, together with small group focused Town Hall meetings, we will increase caring and respectful behaviors between members of the Munhall community. Staff will participate in professional learning related to processes for and use of critical conversations to build collaborative team efficacy.
