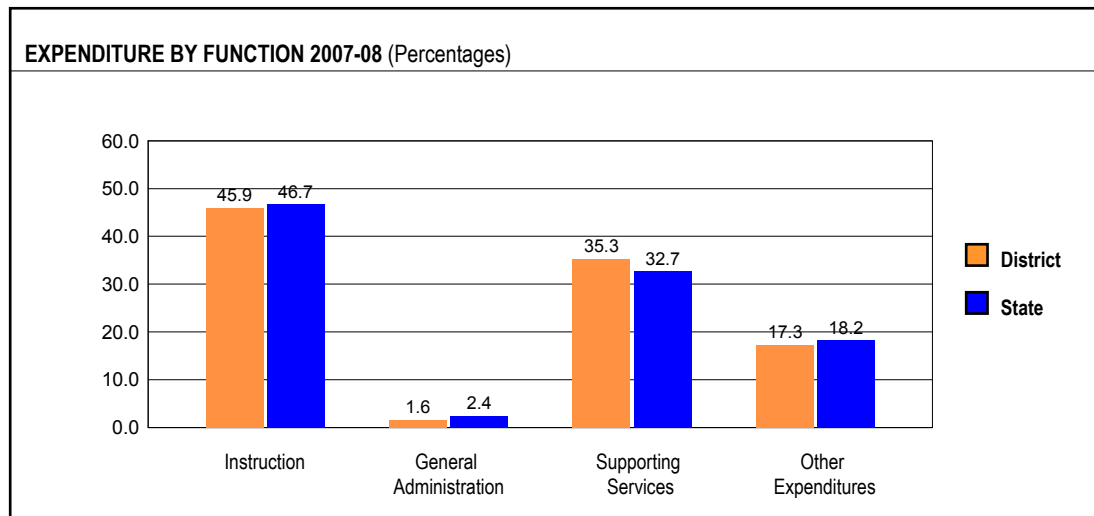

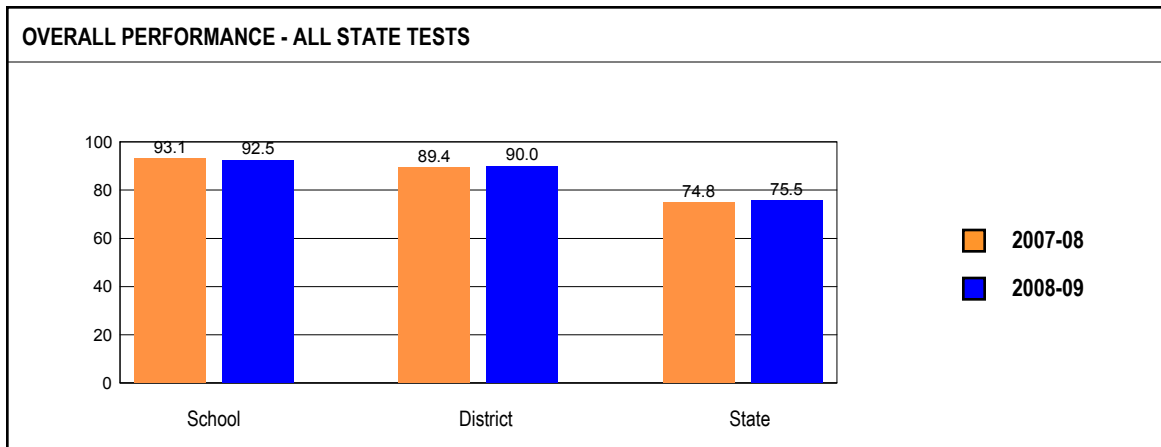

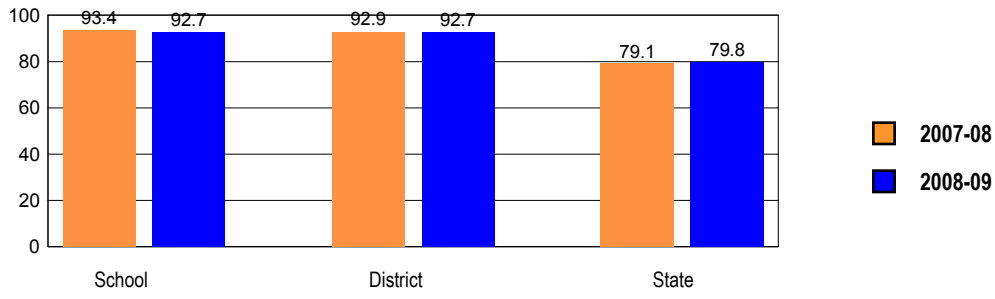
OVERALL STUDENT PERFORMANCE

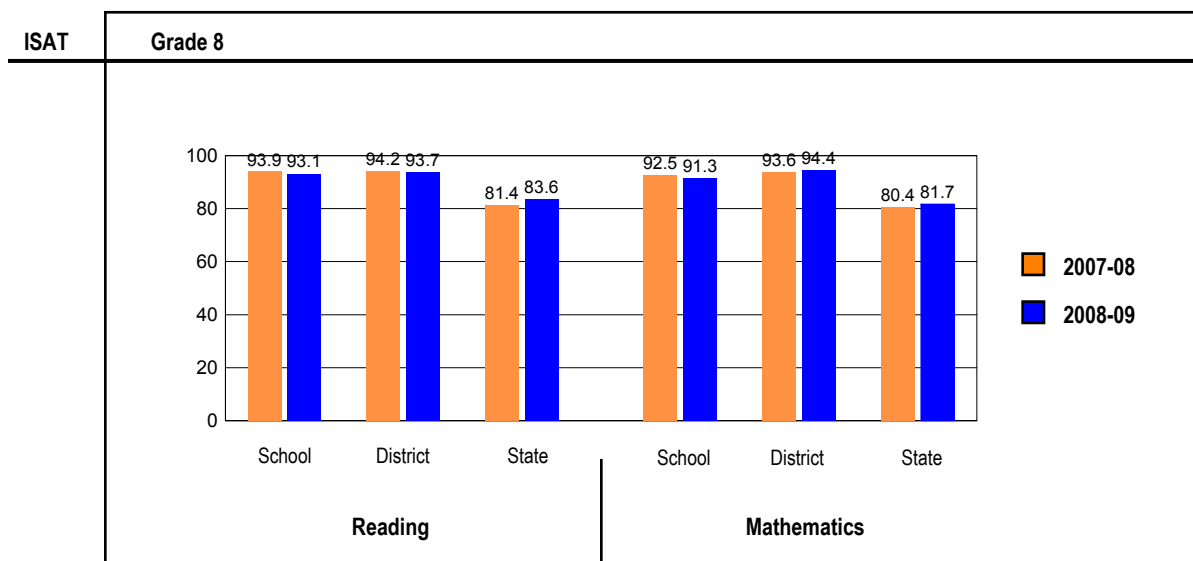
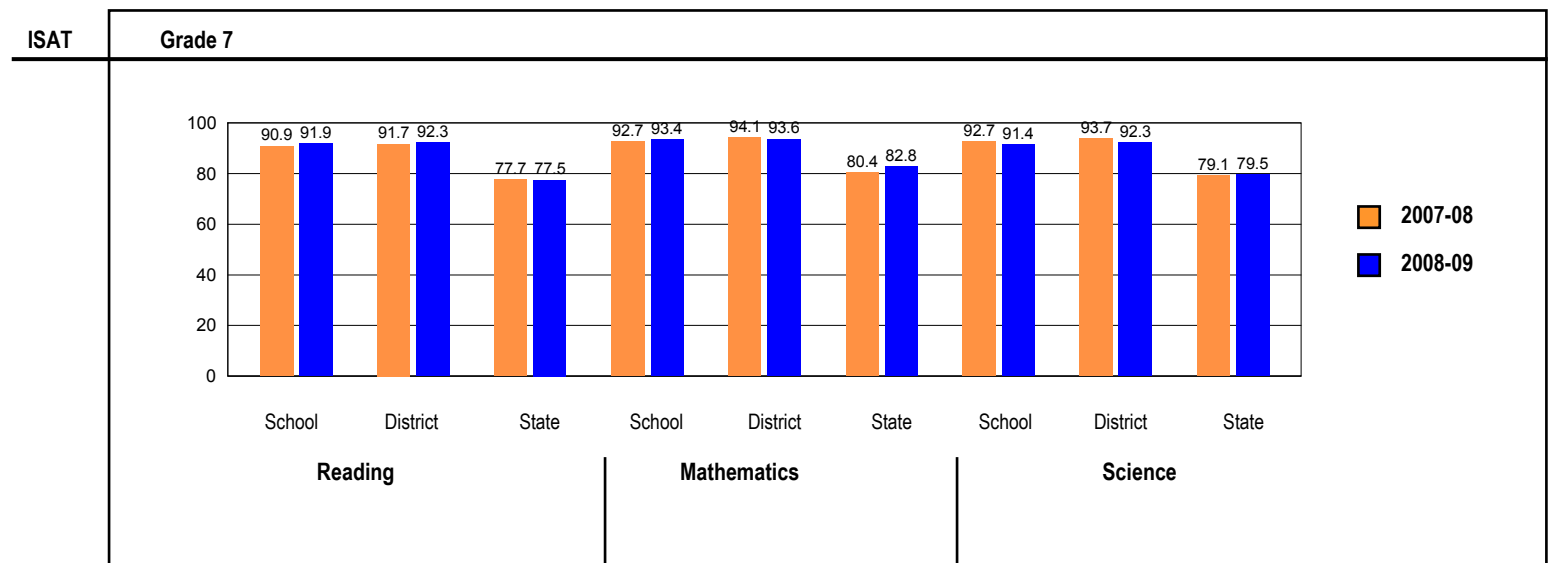
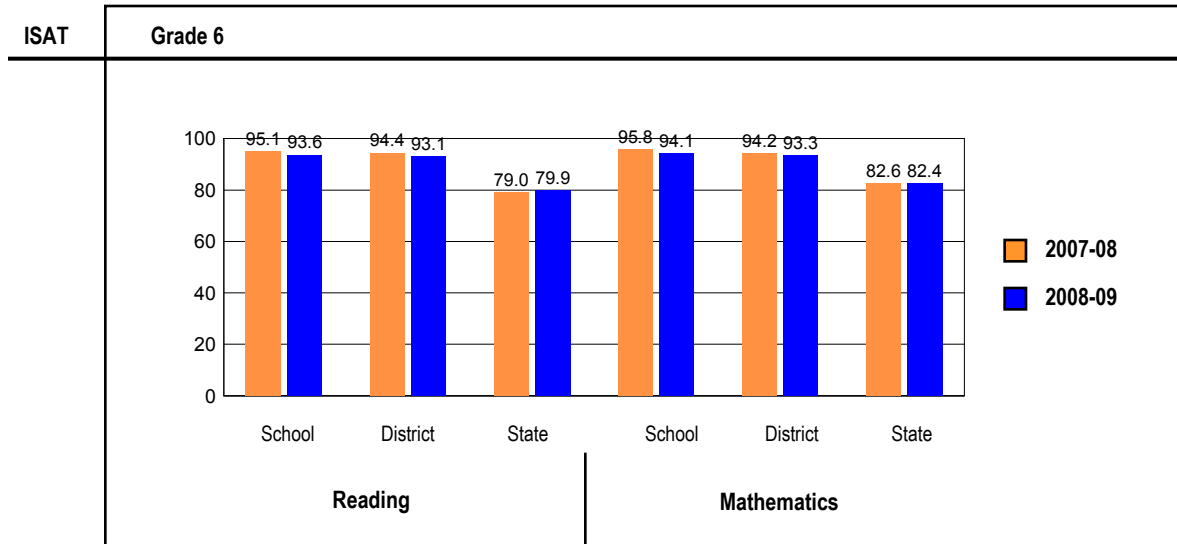


OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE

PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.

Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.

Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.

Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

Four Conditions Are Required For Making Adequate Yearly Progress (AYP):

1. At least 95% tested in reading and mathematics for every student group. If the current year participation rate is less than 95%, this condition may be met if the average of the current and preceding year rates is at least 95%, or if the average of the current and two preceding years is at least 95%. Only actual participation rates are printed. If the participation rate printed is less than 95% and yet this school makes AYP, it means that the 95% condition was met by averaging.
2. At least 70.0% meeting/exceeding standards in reading and mathematics for every group. For any group with less than 70.0% meeting/exceeding standards, a 95% confidence interval was applied. Subgroups may meet this condition through Safe Harbor provisions. ***
3. For schools not making AYP solely because the IEP group fails to have 70.0% meeting/exceeding standards, 14% may be added to this variable in accordance with the federal 2% flexibility provision.
4. At least 90% attendance rate for non-high schools and at least 78% graduation rate for high schools.

*** Subgroups with fewer than 45 students are not reported. Safe Harbor only applies to subgroups of 45 or more. In order for Safe Harbor to apply, a subgroup must decrease by 10% the percentage of scores that did not meet state standards from the previous year plus meet the other indicators (attendance rate for non-high schools and graduation rate for high schools) for the subgroup. For subgroups that do not meet their Safe Harbor Targets, a 75% confidence interval is applied. Safe Harbor allows schools an alternate method to meet subgroup minimum targets on achievement.

Wredling Middle School Improvement Plan for 2009-2010

Wredling Middle School is committed to learning for all! As you have seen, Wredling's scores are significantly higher than the state. For more general purposes, to reach 100% of our students meeting standards, we have designed school improvement goals and action plans. Our overall performance demonstrates 92.7% of our students meet and exceed state standards. We continue to make AYP and devote our efforts to ensure all students succeed.

In reading, we will increase the percentage of students meeting or exceeding standards by 2%. We have so few students not meeting reading standards that we identify them by name and design plans accordingly. To increase our math by 1%, we will continue to work on number sense and algebra. Ongoing tips for parents will be provided through our website.

Reading Goal for the Current Year

Our reading goal focuses on student improvement for those not meeting standards. We are working to identify areas of individual student need and write goals to help reach those areas. Teachers will be using their professional learning community times to determine essential learnings and write formative and summative assessments to check for understanding. Additionally, data through Tungsten testing will provide PLC's with necessary information for student learning. We have added additional supports through our Reading Plus computer program. This program is designed to help students build vocabulary, silent reading fluency, comprehension, and confidence. Students will be identified and provided with opportunities to use this program throughout the year. We will continue to challenge those meeting to move to exceeds area in reading. 44.8% of our sixth graders exceed in reading while only 17.0% of our eighth grade students exit exceeding in reading. This is an area of concern as we work to challenge students to perform at the highest level.

Math Goal for the Current Year

Our math goals focus on improving number sense and algebra for all. Specific action plans address these areas and are being implemented school wide. Opportunities to incorporate computation, operations, estimation, and algebra skills are being implemented building wide. Math professional learning communities will continue to review formative and summative assessments, as well as Tungsten data to work with students' still needing practice and reinforcement in these areas. Math teachers will be providing extra time for students before and after school as well as our math resource opportunity on Tuesday and Thursday afternoons. Our math scores are impressive and we will continue to challenge those in meeting category to move to exceeds on the ISAT. 48.6% of our sixth graders exceeded while 41.2% of our eighth grade students exceeded in 2008-2009.
